 - b) Graduation Degree/Certificate
 - c) Transfer Certificate/Migration/Self Declaration
 - d) Migration Certificate
 - e) Three copies of passport size photographs
 - f) Caste Certificate issued by the competent authority
 - g) EWS Certificate, if applicable.
 - h) Fee Receipt (The UTR /Transaction Id/Date should be informed to this office by email)
- 3. At the time of physical verification of the documents, all the original certificates/documents will be required. Transfer Certificate and Migration Certificate (in original) will be kept by this office.
- 4. Scan copy of the certificate in original in pdf format will be accepted only, scan copy from photocopy will not be accepted).
- 5. All the filled in forms with certificates should reach the IGRMS on or before 18th January, 2021 till 6.00 pm.
